RESOLUTION OF THE TOWNSHIP OF WHITE, COUNTY OF INDIANA AND COMMONWEALTH OF PENNSYLVANIA, CORRECTING AND MODIFYING THE WHITE TOWNSHIP AGRICULTURAL SECURITY AREA, AS SET FORTH IN WHITE TOWNSHIP RESOLUTION NO. R-9-06

WHEREAS, the White Township Board of Supervisors has established an Agricultural Security Area consisting of thirty-four parcels of land located in White Township, as set forth in White Township Resolution No. R-9-06, all in accordance with the Act of June 30, 1981, P.L. 128, No. 43, known as the "Agricultural Area Security Law", and

WHEREAS, Resolution No. R-9-06 included in its listing of properties lands owned by Margaret C. Blosser, Tax Parcel No. 42-05-127 and containing 81.07 acres; and

WHEREAS, at the time of adoption of Resolution No. R-9-06, it was intended that Tax Parcel No. 42-05-127 should be removed from the White Township Agricultural Security Area, as witnessed by the recommendations of the White Township Planning Commission in their September 12, 2006 Report to the White Township Board of Supervisors; and

WHEREAS, the White Township Board of Supervisors wishes to correct this error in Resolution No. R-9-06 by removing Tax Parcel No. 42-05-127 from the White Township Agricultural Security Area; and

WHEREAS, by adoption of Resolution No. R-5-08, the White Township Board of Supervisors did modify the Agricultural Security Area by adding Tax Parcel No. 42-04-118 owned by Mr. Wilfred C. Meyers and Mr. James E. Meyers, all in accordance with the Act of June 30, 1981, P.L. 128, No. 43, known as the "Agricultural Security Law", and

AND NOW, BE IT RESOLVED, that the Supervisors of the Township of White, County of Indiana and Commonwealth of Pennsylvania, do hereby modify the agricultural security area solely within the Township of White, County of

Indiana and Commonwealth of Pennsylvania in accordance with the provisions of "Agricultural Area Security Law" of the Commonwealth of Pennsylvania, Act of June 30, 1981, P.L. 128, No. 43 comprising the following properties within the Township of White, County of Indiana and Commonwealth of Pennsylvania, as follows:
